



BIOGRAPHY - Dr. Michel Henry Bouchet

米歇尔-亨利·布歇博士简历

Dr. Bouchet is currently Distinguished Finance Professor at SKEMA Business School. He is also Managing Director of DEFI-Developing Finance, and Board member and chief Strategic Consultant of North Sea-Global Equity Management Fund (Norway).

布歇教授目前是法国商科联盟国际商学院 (SKEMA Business School) 金融学教授, 他也是 DEFI 开发性金融总经理并担任北海-环球股票管理基金董事会成员和首席战略顾问。

Dr Bouchet graduated in Economics from the University of Paris X, and from the Paris-based Institut d'Etudes Politiques. He also holds Master and Ph.D degree in International Relations from USC, Columbia, USA. He got his HDR (Director of Doctoral Research) from Université Paris-Dauphine.

布歇教授同时毕业于巴黎第十大学和巴黎政治学院经济学专业。他在南卡罗来纳哥伦比亚大学获得国际关系硕士及博士学位, 在巴黎第九大学获得了特许任教资格。

Dr Bouchet started his career at Secrétariat Général de la Défense Nationale (SGDN). He has then held high-level positions in international banking, including BNP (country risk management), World Bank (Senior Economist-financial engineering assistance) and Institute of International Finance (Senior international economist) in Washington, D.C. In 1990, he founded Owen Stanley Financial SA which he served as its CEO. The company, a global advisory firm dealing with debt restructuring strategy in emerging markets, became a subsidiary of ING Barings. Until end-2001, he was Principal Advisor of ING Barings as well as executive partner of FINCONET. Between 1998 and 2009, he was Academic Director of MSc in International Finance at SKEMA-Business School, ranked 9th by the Financial Times (2011).

布歇博士从法国国防总秘书处的岗位上, 开始了自己的职业生涯。随后他在包括法国巴黎银行 (国家风险评估师)、世界银行 (高级经济师-金融工程助理) 和位于华盛

顿特区的世界金融研究所（高级国际经济师）等国际性银行担任高级职位。1990年，他成立了欧文斯坦利金融公司并担任首席执行官。该公司是一家致力于为新兴经济体制定债务重组战略的全球咨询公司，现已成为荷兰霸菱集团的子公司。直至2001年底，布歇博士同时担任荷兰霸菱集团的首席顾问和国际金融消费权益保护网络的执行合伙人。从1998年到2009年，他是SKEMA商学院国际金融硕士项目的学术主任。该硕士项目在《金融时报》的排名中，位列第9位。

Dr. Bouchet has been International Affiliate Professor at ESAN (Lima) and Visiting Lecturer at CFVG-ESCP (Saigon & Hanoi) and at Sfax Business School (Tunisia), as well as in China's Zhejiang University and Suzhou University. He is regular keynote speaker in commercial business meetings and international conferences. In 2005 he was Visiting Scholar at Asian Institute of Technology's School of Management. He is Reviewer of the International Business Review and on editorial boards of International Journal of Islamic, Middle Eastern Finance, and of Journal of Economics, Finance and Administrative Science. He is also Expert Witness in International Arbitrage Courts. Dr. Bouchet is member of the World Economics Association and of Transparency International-France.

布歇教授曾经在秘鲁工商管理研究生院（ESAN）、法国-越南管理学教育中心（西贡和河内）、突尼斯的斯发克斯商学院、浙江大学和苏州大学担任客座教授。他经常在国际商业会议和研讨会上担任主讲人。2005年，他在亚洲理工学院管理学院做访问学者。同时他是《国际商业评论杂志》的评论家，和《国际伊斯兰和中东财政杂志》，《经济金融和管理科学报刊》的编委。布歇博士是国际仲裁法院的专家证人、也是世界经学协会和《透明国际（法国）》的成员。
